RE: Concurrent Enrollment Report

Dear Governor Newsom:

Education Code section 76002 requires the Chancellor's Office to prepare and submit a report each year on the number of full-time equivalent students (FTES) claimed by each community college district for special part-time and special full-time students for the preceding academic year in each of the following class categories:

- Noncredit
- Nondegree-applicable
- Degree-applicable, excluding physical education
- Degree-applicable physical education

Table 1 summarizes the number of FTES claimed for special part-time and special full-time students for each community college district in 2018-19. Table 2 shows systemwide FTES data for multiple fiscal years.

Education Code section 48800 requires the Chancellor's Office to report the number of systemwide summer session students with passing grades for multiple fiscal years. Table 34 displays that data, showing year-to-year percentage change.

The FTES data included in the tables is consistent with the data reported in the Chancellor's Office Data Mart. However, Data Mart FTES varies from the FTES reported for funding purposes due primarily to differences in timing of submissions between the two reports.

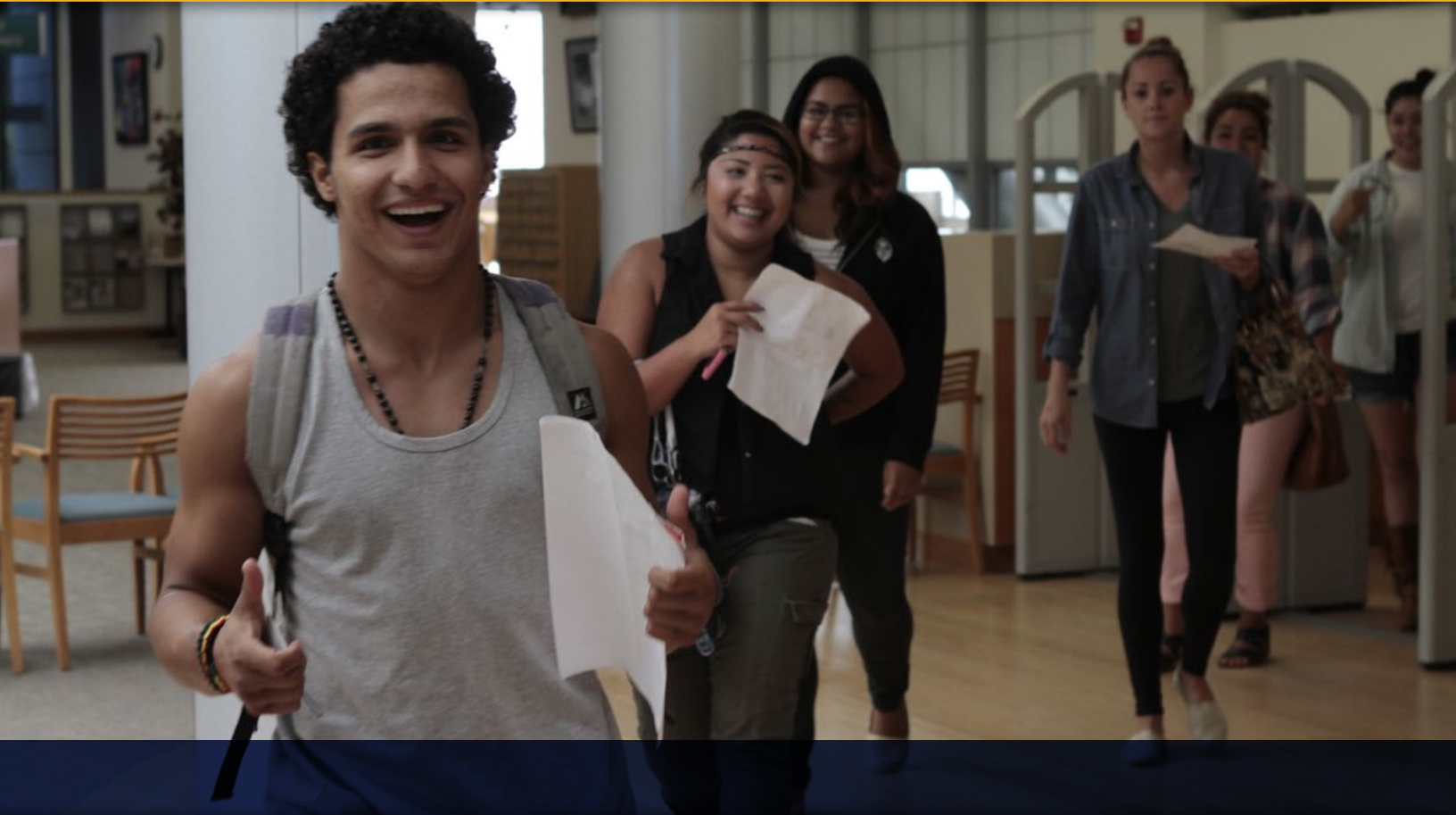
