Digest Item 1.2: Chancellor's Office Update

(Chancellor Christian)

The Chancellor’s Office (CO) presented updates on relevant developments and time-sensitive changes since the previous Consultation Council meeting, as well as digest items previously presented that may require additional consultation.

Discussion Summary:

- CCA/CTA requested further discussion on Dual Enrollment.
- CO announced plans requesting feedback from the Council on Vision 2030.
- CSEA commented on the CSEA Community College Committee and discussions on dual enrollment engagement with K-12.
- CCLC voiced support for the work on this digest item.
- FACCC raised discussion on dual enrollment expansion.
- CCA/CTA voiced support for the work on this digest item and raised discussion on support for Career Technical Education (CTE) workforce development programs.

Digest Item 1.3: Student Senate Update

(SSCCC President Tervalon and VPLA Wooden)

This digest item presented updates on the SSSCC current initiatives, legislative stances, system participation, and the status of the SSSCC Board of Directors.

Discussion Summary:

Digest Item 1.4: Proposed Regulatory Action: Supervised Tutoring

(Executive Vice Chancellor Lowe)

This digest item presented revisions to the proposed language, which have been incorporated and will be presented for a second reading and action at the July Board of Governors meeting.

Discussion Summary:

- CCA/CTA inquired about anticipating increases in supervised tutoring in noncredit full-time equivalent students (FTES).
- SSSCC encouraged more student services programs.
- ASSCC voiced support for the work on this digest item.

Digest Item 1.5: Proposed Regulatory Action: Associate Degree

Requirements

(Executive Vice Chancellor Lowe and General Counsel LeForestier)

This digest item was a first reading of a proposed regulatory action to revise regulations governing the requirements for the associate degree.

Discussion Summary:

- CCA/CTA requested clarification on the Associate Degree requirements regarding the new singular transfer pattern California General Education Transfer Curriculum (Cal-GETC).
- CCA/CTA and ASCCC inquired about the difference between an introductory and an integrative baccalaureate level course.
- ASCCC commented on developing the general education (GE) pattern to align with Cal-GETC and students meeting course requirements.
- CCCI commented on the opportunities for adult learners and recredentialing.

Digest Item 1.6: State and Federal Update

(Vice Chancellor O'Brien)

This digest item provided the Council with an update on state and federal policy issues and legislation.

Discussion Summary:

- SSCCC inquired about Chancellor's Office meetings with Senate members and updates on positions taken.
- CSEA requested updates on the Governor's budget and inquired about districts on the Student Centered Funding Formula (SCFF).
- CCCT requested removal of restrictions on the research requirements programs.
- ASCCC expressed concerns with Assembly Bill (AB) 1749.
- CCLC expressed concerns with AB 689.

Digest Item 1.7: Professional Development for Classified Professionals and Part-Time Faculty Update

(Executive Vice Chancellor Navarette and Assistant Vice Chancellor Martinez)

This digest item provided the Council with an update on Classified Professionals and Part-Time Faculty Professional Development needs assessment and the subsequent actions aligned to the recommended actions.
